and kept in good repair, and Lessors agree to indemnify the Lesses from and against any loss or damage to property of Lessees which may be installed or placed in the building or buildings covered by this lease, provided said loss or damage is caused by a defective or leaky roof.

FOURTH: That all property of any kind that may be placed on the premises during the continuation of this lease shall be at the sole risk of Lessees, and that the Lessors shall not be liable to the Lessees or any other person or persons for any injury, loss or damage to property or person occurring on the premises or as a result of Lessee's operation of its business.

FIFTH: That in the event said building or buildings covered by this lease become or are made untenantable by any act or neglect on the part of the Lessers or if said building or buildings are destroyed by fire or in whole or in part by an act of God such as rain, wind, flood or earthquake, then in any such event, Lessees will be released from further performance of the terms of this lease, provided however that in the case said premises shall be damaged by fire or other unavoidable casualty, the Lessor shall at his own cost repair the same. But if the premises shall thereby be rendered untenantable in whole or in part, the Lessees will be relieved from payment of rent until such a time as the building or buildings become tenantable.

SIXTH: Provided, always, in these presents, or upon this condition, that if the Lessees or their representatives or assigns shall neglect or fail to perform and observe any covenant or condition herein contained, which on the Lessees part is to be performed, or if the leasehold estate shall be taken on execution, or if the Lessees or their assigns shall be declared bankrupt or insolvent according to law or shall make an assignment for the benefit of
