Riddle made September, 1926, the following metes and bounds, to-wit:

BEGINNING at a rock on road leading to Pelzer, S. C., and running thence with said road N. 11 W. 534 feet to pin; thence S. 86.15 W. 810 feet to pin; thence S. 46 E. 2980 feet to a pin on corner of Lot No. 2; thence with line of Lot No. 2, S. 23.40 W. 1398 feet to a stake on branch; thence with meanders of branch 2136 feet to a point on branch; thence to a sweet gum; thence N. 32.15 W. 132 feet; thence N. 22 W. 792 feet to a rock pile; thence N. 87 W. 977 feet to the beginning.
