

BEGINNING at an iron pin in a proposed road, which point is S. 22-14 W. 279.5 feet from a point in a private road, and running thence S. 22-14 W. 306 feet to an iron pin; thence West 143.5 feet to an iron pin; thence N. 18-23 W. 108 feet to an iron pin on the Eastern bank of Saluda Lake; thence along the Eastern bank of said lake N. 40-15 W. 71.8 feet to an iron pin; thence continuing along the Eastern bank of said lake N. 22-10 W. 50 feet to an iron pin in the line of 2.21 acre tract; thence with the line of said tract N. 52-35 E. 228 feet to an iron pin in a proposed road; thence with the center of said proposed road S. 46-21 E. 87 feet to an iron pin; thence continuing with center of said proposed road S. 76-55 E. 76.1 feet to an iron pin; thence still continuing with center of said proposed road N. 66-27 E. 44.2 feet to the point of beginning.
