All that lot of land in the City and County of Greenville, State of South Carolina being known as lot no. 14 and a small portion of lot no. 13 according to plat of Pleasant View made by C. C. Jones dated February, 1954 and recorded in the R.E.C.Office for Greenville County in Plat Book HH at Page 52 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northwestern side of Willow Springs Drive, at the joint front corner of lots 14 and 15 and running thence along the line of lot 15, N 80-52 E, 100.1 feet to an iron pin; thence N 5-12 E, 12.6 feet to an iron pin in the line of lots 13 and 15; thence through lot 13 on a new course S 52-51 E, 98.2 feet to an iron pin on the northwestern side of Brookdale Avenue (which iron pin is situate 12 feet northeast of the original joint front corner of lots nos. 13 and 14); thence with the northwestern side of Brookdale Avenue along the curved line of said avenue, the chord of which is S 31-45 W, 133.5 feet to an iron pin; thence with the curved intersection of Willow Springs Drive and Brookdale Avenue, the chord of which is S 78-37 W, 36.4 feet to an iron pin on the northwestern side of Willow Springs Drive; thence with Willow Springs Drive, the chord of which is N 32-43 W, 89.5 feet to an iron pin; thence continuing N 10-48 W, 85 feet to the point of beginning.

Grantee assumes and agrees to pay that certain note and mortgage executed to South Carolina National Bank which balance is \$6,071.67 recorded in mortgage book 628 at page 317.
