

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JAMES T. JENKINS, HIS HEIRS AND ASSIGNS FOREVER,

ALL that certain piece, parcel or lot of land located in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 5 on the plat of the subdivision of Frank A. Richerson and Lillie Mae Richerson known as "GLYNHAVEN COURT"; said plat being made by J. Mac Richardson, R.L.S., dated April, 1955, and recorded in the R.M.C. Office for Greenville County in Plat Book "II", at page 157, said lot having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwestern side of Glenmore Drive, joint front corner of Lots Nos. 6 and 5, and running thence with the common line of said lots, S. 24-19 W. 205.1 feet to an iron pin on the line of property (now or formerly) of E. M. Cromer, joint rear corner of Lots Nos.6 and 5; thence running along the rear line of Lot No. 5, S. 64-26 E. 70 feet to an iron pin, joint rear corner of Lots Nos. 5 and 4; thence running with the common line of said Lots Nos. 5 and 4, N. 24-19 E. 206.5 feet to an iron pin on the Southwestern side of Glenmore Drive, joint front corner of Lots Nos. 5 and 4; themse along the Southwestern side of Glenmore Drive and the front line of Lot No. 5, N. 65-36 W. 70 feet to the iron pin at joint front corner of Lots Nos. 6 and 5, the point of beginning. This being a portion of the property conveyed to us by Ruth E. Chapman et al, by deeds dated December 14-28, 1954 and January 5, 1955, and recorded in the R.M.C. Office for Greenville County in Deed Book 516, pages 383-400.
