FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is MATIONAL DISTRIBUTORS, INC., GREENVILLE

THIRD: That the principal place of business is 5 Peden St., Greenville, J. C.

FOURTH: That the general nature of the business which it is proposed to do is to engage in the general wholesale distributing business and act as sales agent of household furnishings, and other commodities with the right to buy, sell, own, hold and deal in stocks, bonds, mortgages, real estate and personal property of any and every nature.
