All that piece, parcel or lot of land located in Gantt Township, Greenville County, in subdivision off White Horse Road known as White Horse Addition according to plat made by J. C. Hill, May 15, 1951 recorded in R. M. C. Office for Greenville County in Book "W" page 187, said lot being number 15 on Spears Drive, and being more particularly described as follows:

BEGINNING at an iron pin on the North Side of Spears Drive, at the joint corners of lots 14 and 15; thence along said Spears Drive S. 77- W. 75 feet to an iron pin; thence N. 13- W. 204.4 feet to an iron pin; thence N. 79-05 E. 75 feet to an iron pin; thence S. 13- E. 201.7 feet to an iron pin on Spears Drive, the point of beginning.

Restrictions:

1. Said lands shall not be sold, rented or otherwise disposed of to person of African descent.
2. No residence is to cost less than \$4000.00 and no residence shall be erected on said lot nearer than 50 feet to the front line.
3. No outside toilets are permitted and sewage is to be disposed of by approved septic tanks.

This deed is made subject to any easements or rights of way now existing.  
Grantees to pay taxes for the year 1955.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining  
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
