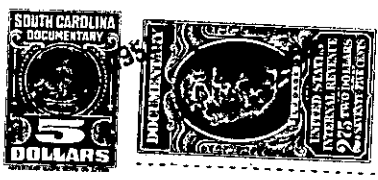

All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, on the Western side of Elizabeth Drive, being shown as Lot No. 325 on Plat of Cherokee Forest recorded in the R.M.C.
