payments shall constitute a default in this Contract.

The fire and casualty insurance policy now carried by the Seller chall be pre-rated as of the date of the execution hereof and it shall be the obligation of the Eugers to thereafter carry fire and casualty insurance in the amount of (5,000.00, or the full insurable value of the property, whichever is smaller. Said policy shall be in the name of the Eugers and the Seller, as their interest may appear, and shall be held by the Seller. Destruction or damage of or to the promises shall not release the Eugers from this Contract.

In the event of a partial destruction of the premises, any procoods received under the policy shall be used to repair the premises. Failure to maintain said policy shall consitute a default.

The Buyers agree to maintain the provises and to keep the same in good sepair subject only to normal usar and tear. The failure of the Buyers to comply with this provision shall constitute a default.

It is expressly stipulated that the Seller shall have the right to mertgage the premises in an amount not to exceed the outstanding balance due at the time of the mortgage on this Contract.

The Seller variants that any such mortgage placed on the promises by her shall be estimated and cancelled at any time that she is obligated to came to a fee simple doed to the promises herein described to the Eugers.

The Eugers variant and covenant that they shall be obligated to accept a deed from the Seller to the promises at any time that the Seller may arrange for a note and mortgage from the Eugers to any person or agencies for the remaining amount due hereunder at an interest rate not in excess of six persont and for payments with an average of not in excess of Fifty (\$50.00)

It is agreed that time is the essence of this Contract and if payments immunder are not made when due, the Seller may, at her option, upon two months default in payments, be discharged from any and all liability in law and equity to make said deed and the down payment shall be considered as liquidated damages and the monthly payments shall be treated and considered
