

All that piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot ! . 18, Property of Central Development Corporation, as per plat theroof, recorded in the R. I.C. Office for Greenville County in Plat Book "BB", Pages 22 and 23, and having, according to said plat, the following metes and bounds, to-wit:
