all that piece, parcel or lot of land in Highland Township, Greenville County, State of South Carolina, on waters of South Tyger River, near Camp Creek Baptist Church, bounded on the North by lands of W.W. Hempley. on the East by lands of V.G. Hightower, on the South by lands of James A. Hightower and on the West by lands of Mrs. Ida Brown, having the following lines and courses, to wit: Beginning on a stone on branch near where old engine house stood and on South side of road, and thence down meanders of the branch to point on James A.
