OLL S FARICHOR AGREEMENT

AGREEMENT made this 27 Hay of November, 1955 by and between Albert A. Broadnax and Sarah I. Broadnax, hereinafter called the first party, and H. H. Babb and Semerinis Babb, hereinafter called the second party, all of the aforesaid County and State, WITNESSETH:

WHEREAS the first party on or about March 29, 1955.

instituted an action against the second party in the Greenville County Court for the possession of property under which the second party had installed a water line and for order of Court requiring second party to remove said pipe line. The property involved is fully described by metes and bounds by deed recorded in Greenville County R.M.C. Office in Deed Book 514, at page 159.

Now, therefore, the parties herein have agreed to a compromise settlement in the dispute as to the water line heretofore mentioned, and the party of the first part having this day executed a right-of-way agreement over and along the boundary of his property as more fully set forth in right-of-way agreement executed this date, the party of the second part in consideration of the same does hereby agree to release from hisright of way which has been recorded in the R.M.C. Office for Greenville County in Deed Book 520, at page 443 the original right-of-way as now located, but in nowise shall it affect the remaining described premises or rights of the party of the second part with any other parties. It is agreed that the party of the first part will grant a right of way of approximately 2 feet in width and running the distance as shown in right of way deed dated this date.

It is hereby mutually agreed between the parties that they will as soon as possible have installed one inch galvanized pipe at least 24 inches under the ground of this right of way and the costs of removal of existing pipe line and installation in its new position, cost of necessary new pipe and cost, if any, to Greenville City Water Works will be
