It is further agreed and understood between the parties hereto that in the event of distruction of said building by fire or other hazard, said Lease would not be terrinated, but the Lessors would be given a reasonable period of time in which to repair or re-erect said building, and in the interim said Lessee would not be liable for the payment of any rent while said premises are not being occupied.

TO HAVE AND TO HOLD the said premises unto the said Tessee, its successors and assigns, for the said term.

The Lessee agrees to make good the breakage of miss and all other injuries done to the premises during the term of said Lease, except such as are produced by natural decay and wear and tear.

The Lessee hereby acknowledges having a duplicate of this Lease.

IN WITHESS THEREOF, E. A. Powen and Rosa O. Powen, as Lessons, and B. W. Krell, President of Dixie Radio Supply Company, Inc., and W. C.
