



BEGINNING at an iron pin on the Southern side of East Belvedere Rold at the joint front corner of Lots 3 and 4 and running thence with the Southern side of East Belvedere Road N. 52-50 £. 26.2 feet to an iron pin in the front line of Lot 4; thence continuing with the Southern side of East Belvedere Road N. 45-26 E. 223.2 feet to an iron pin at the joint front corner of Lots 6 and 7; thence with the common line of said two Lots, S. 44 - 34 E. 140 feet to an iron pin; thence with the rear line of Lots 6 and 5 S. 45-26 W. 170 feet to an iron pin at the joint rear corner of Lots 5 and 4; thence with the rear line of Lot 4 S. 59-22 W. 111.5 feet to an iron pin at the joint rear corner of Lots 4 and 3; thence with the common line of said two lots N. 30-38 W. 120.6 feet to an iron pin, the point of beginning.
