W. M. EDWARDS AND W. E. CALDWELL, Their Heirs And Assigns,

ALL that certain piece, parcel or lot of land in Chick Springs Township, Green-ville County, South Carolina, being known and designated as Lots No. 33 and 34 as shown on plat of Pine Brook Extension made by W. N. Willis, Engineer, in June, 1953, recorded in the R.M.C. Office for Greenville County in Plat Book W, at Page 73, and having according to said plat, the following metes and bounds,

BEGINNING at an iron pin on the Eastern side of Cardinal Drive, joint front corner of lots 34 and 35, and running thence along the common line of said lots, N. 38-12 E. 192.2 feet to an iron pin, joint rear corner of said lots; thence along line of other property of Grantors, N.73-50 W. 110 feet to an iron pin; thence continuing along line of other property of Grantors, N.10-0 W. 153.3 feet to an iron pin at edge of transmission line right-of-way; thence along said right-of-way, S.73-06 W. 180 feet to an iron pin on Cardinal Drive; thence along Cardinal Drive, S.27-49 E. 143.3 feet to an iron pin; thence S.41-35 E. 75.5 feet to an iron pin at joint front corner of lots 33 and 34; thence continuing along Cardinal Drive, S.41-35 E. 70 feet to an iron pin; thence continuing along Cardinal Drive, S.27-55 E. 50 feet to an iron pin, the point of the beginning.
