

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said GLADYS H. SIMMONS, her heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon situate on the . East side of Trails End in the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 85 and the Southern one-half (1/2) of Lot No. 86 adjacent thereto, as shown on plat of Cleveland Forest, made by Dalton & Neves, Engineers, May, 1940, recorded in the RMC Office for Greenville County, S. C., in Plat Book "M", at pages 56 and 57. and having according to said plat the following metes and bounds, to wit;

BEGINNING at an iron pin on the East side of Trails End at joint front corner of Lots 33 and 85, and running thence with the line of Lot 33, N. 54-35 E., 177 feet to an iron pin on the West edge of Nichol Town Road; thence with the West edge of Nichol Town Road, N. 26-35 W., 90 feet to an iron pin in the center of the rear line of Lot 86; thence through the center of Lot 86, S. 54-35 W., 175.1 feet to an iron pin in the center of the front line of Lot 86 on the East side of Trails End; thence with the East side of Trails End, S. 25-25 E., 90 feet to the beginning corner.

C., Executor of the Estate of W.C.Cleveland, deceased, and Alice Burnett Cleveland, Executrix of the Estate of W.C.Cleveland, dated September 18, 1951, recorded in RMC Office for Greenville County, S.
