ALL that piece, parcel or lot of land in Saluda Township, Greenville County, South Carolina, being all of Tract No. 1 conveyed to C. R. Thompson by Deed of L. Inman, Master, dated July 23, 1940, recorded in the R. M. C. Office for Gre nville County, South Carolina, in Deed Book 224, page 58, containing 28-3/4 acres, more or less, less, however, 17-3/10 acres previously conveyed by C. R. Thompson to Daisy Revis by Deed dated April 18, 1946, recorded in the R. M. C. Office for Greenville County, South Carolina in Deed Book 293, Page 253.
