LOT NO. 41: Beginning at the Northern edge of Laurel Drive at joint front corner of Lots 40 and 41 and running thence along the joint line of Lots 40 and 41, N.39-33 E., 155.2 feet to corner; thence N. 62-11 W., 90 feet to joint rear corner of Lots 41 and 42; thence S. 26-30 W., 150.7 feet to joint front corner of Lots 41 and 42 on the Northern side of Laurel Drive; thence along the Northern side of Laurel Drive, S. 60-51 W., 55 feet to the beginning corner.
