

BEGINNING at an iron pin on the northwestern side of Central Avenue at the joint front corner of lots # 2 and 3, said pin being 100 feet northeastern direction from the point where northwestern side of Central Avenue intersects with northeastern side of Marshall Avenue; running thence with line of lot #2, N. 41-54 W. 140 feet to an iron pin; thence N. 48-06 E. 50 feet to an iron pin at the corner of lot #4, thence with the line of lot # 4, S. 41-54 E. 140 feet to iron pin on Northwestern side of Central Avenue; thence with Northwestern side of Central Avenue, S. 48-06 W. 50 feet to the beginning comer.
