BECINNING at an iron pin on the West side of Williamsburg Drive, said iron pin being 120 feet in a Northerly direction from the intersection of Williamsburg Drive and Brook Forest Drive, at the joint front corner of lots # 34 and 48, and running thence with Williamsburg Drive, S. 11-33 W. 120 feet to an iron pin; thence with the curve of the intersection of Williamsburg Drive and Brook Forest Drive, the chord of which is S. 71-01 W. 30.5 feet to iron pin on Brook Forest Drive; thence with said Brook Forest Drive, N. 49-10 W. 68.5 feet to an iron pin; thence continuing with said Drive, N. 41-54 W. 75 feet to an iron pin; thence with line of lot # 35, N. 57-52 E. 84 feet to an iron pin; thence with line of lot # 48, S. 78-11 E. 86.2 feet to the point of beginning.
