

KANE in consideration of the sum of One Thousand Two Hundred Fifty (\$1,250.00)----- DOLLARS, and assumption of the below mentioned mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Wenard Bowser, Jr. and Jane G. Bowser:

ALL that piece, parcel, or lot of land, with the buildings and improvements thereon, in Gantt Township, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 157 of Belle Meade Subdivision, a plat of which is recorded in the R. M. C. Office for Greenville County, South Carolina, in Flat Book EE, at Pages 116 and 117, and, having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of East Dorchester Boulevard at the joint front corner of Lots Nos. 156 and 157, which iron pin is 100.5 feet in a westerly direction from the southwest intersection of East Dorchester Boulevard and Edgefield Road, and running thence with the joint line of said lots, S 14-50 W 150 feet to an iron pin at the rear joint corner of said lots; thence N 75-10 W 70 feet to an iron pin at the rear joint corner of Lots Nos. 157 and 158; thence along the joint line of said lots, N 14-50 E 150 feet to an iron pin in the line of East Dorchester Boulevard at the joint front corner of said lots; thence along the south side of East Dorchester Boulevard, S 75-10 E 70 feet to the point of beginning.

Being the same conveyed to the grantors by Huguenin & Douglas, Inc. by deed dated June 13, 1955, recorded in said R. M. C. Office in Deeds Book 527, Page 407.

As part of the consideration hereof, the grantees assume and agree to pay the note and the mortgage securing the same, executed by the grantors to General Mortgage Co., dated June 15, 1955, in the original sum of \$14,500.00, the mortgage being recorded in said R. M. C. Of ice in Mortgage Book 641, Fage 479, on which there is a balance as of July 1, 1956 of \$14,178.74.
