The Southeastern corner of this two acre tract and the Northeastern corner of the $2\frac{1}{2}$ acre tract described in deed recorded in Deed Book 166 at page 411 is and should be a common corner and the 2 acre tract recorded in Plat Book Q at page 23 should be faced eastward so that its eastern line and the eastern line of the $2\frac{1}{2}$ acre tract will both run along the same course and constitute a straight line.
