ALL that piece, parcel-or tract of land, with buildings and improvements thereon, situate, lying and being in Austin Township, Greenville County, State of South Carolina, near the Town of Mauldin, S. C. and containing 2.88 acres, more or less, according to a Survey thereof made by C. C. Jones, Engineer, January 21st, 1954 and having the following metes and bounds, to wit:

BEGINNING at an iron pin in the center of the Old Laurens Road, sometimes called the Old Stage Road at corner of property now or formerly of E. L. Griffin; running thence along center of Old Laurens Road, South 41 East 745.1 feet to an iron pin; thence South 83-30 West 395.3 feet to an iron pin; thence South 86-30 West 180.8 feet to an iron pin; thence North 19-45 East 311.5 feet to an iron pin in the Western side of a driveway; thence along the Western side of said driveway, North 7-45 West 316.8 feet to an iron pin on the Northwest side of another drive; thence North 46 East 19.1 feet to the point of beginning and being the same premises conveyed to the Grantor herein by deed of A.
