

Price, Jr. in consideration of the sum of FORTY-FIVE HUNDRED & NO/100 (\$4500.00) - and assumption of a mortgage in the amount of \$1000.00 - - DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Julius B. Aiken, his heirs and assigns, forever: .

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina in Butler Township, lying and being on the East side of S. C. Highway No. 291 and being known and designated as the major portion of Lot No. 7 as shown on plat of property of J. H. 31 Sitton according to Survey made by Piedmont Engineering Service on April 13, 1955 and recorded in Plat Book II, at page 127, RMC Office for Greenville County and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the Eastern side of S. C. Highway No. 291 at the joint front corner of Lots 6 and 7 and running thence along the joint line of said lots, South 87-59 East 189.06 feet to the edge of a 30-foot service alley; running thence along said service alley, South 0-43 West 24.26 feet to an iron pin, joint rear corner of Lots 7 and 8; running thence along the joint line of said lots, North 88-15 West 189.87 feet to an iron pin on the Eastern side of S. C. Highway No. 291; running thence along said Highway, North 1-45 East 25 feet to the point of beginning.

This being the same lot conveyed to the Grantor by deed of J. H. Sitton, et al, recorded in RMC Office for Greenville County in Vol. 524, at page 499 less a small triangular strip conveyed by the Grantor to James P. McNamara and James T. McElrath by deed dated 29 October 1956 and now being recorded. Grantee assumes and agrees to pay Grantor's note and mortgage to J. H.Sitton, et al, in the original amount of \$1000.00, recorded in Vol. 637, page 46. RMC Office
