to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(x) hereinafter named. (the receipt whereof is hereby acknowledged). has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto E. W. HAMPTON:

All that certain piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, being known and designated as the major portion of Lot No. 250 of Section B of Woodfields Subdivision (said lot being shown on a plat of said subdivision, dated January, 1951, prepared by Piedmont Engineering Service and recorded in the R.M.C. Office for Greenville County in Plat Book Z at page 121) and a portion of the Albert Q. Taylor property and being shown on a plat entitled "Plat Showing Property of Woodfields, Inc. and Albert Q. Taylor Adjoining Lot 250" prepared by C. C. Jones, dated May 5, 1954, and recorded in the R.M.C. Office for Greenville County in Plat Book HH at page 95, and having according to said plat and also according to a more recent plat prepared by C.C. Jones, dated January 11, 1955, entitled "Property of Edgar W. Hampton" and recorded in the R.M.C. Office for Greenville County in Plat Book LL at page 125, the following metes and bounds:

BEGINNING at an iron pin on the Southeastern side of Crestfield Road which iron pin is located S. 51-37 W. 10 feet from the original joint front corner of Lots Nos. 249 and 250 and running thence a new line (now the joint line of said lots) S. 41-55 E. 165.4 feet to an iron pin; thence S. 48-05 W. 70 feet to an iron pin; thence N. 45-23 W. 171.5 feet to an iron pin on the Southeastern side of Crestfield Road; thence with the Southeastern side of Crestfield Road N. 51-37 E. 80 feet to the point of beginning.
