All that certain parcel or lot of land situated on the north side of the Hammett's Bridge Road near Pleasant Grove Baptist Church, about 1 mile from Greer, Chick Springs Township, Greenville County, State of South Carolina, being Lot No. 6 of the property of J.H. Greer according to survey and plat by W.P. Forrow, Surveyor, dated July 2, 1955, and having the following courses and distances, to wit: Beginning at an iron pin on north side of Hammett's Bridge Road, corner of Lots Nos. 5 and 6, and running thence along line of said lots, N. 44.30 W. 200 feet to an iron pin; thence S. 42.24 W. 100 feet to iron pin, corner of Lot No. 7; thence along line of same, S. 44.30 E. 200 feet to iron pin on said road; thence along the road, N. 42.24 E. 100 feet to the beginning.

This property shall be used for residential purposes only, and no dwelling house shall be erected on said lot with less than 1150 square feet floor space, not including porches and stoops, and valued at not less than \$9,000.00. A septic tank shall be required for each dwelling, and no outbuildings shall be erected on said lot, except a private garage. No livestock shall be kept upon the premises.
