

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 147, Section II, Oak-Crest, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", pages 130-131, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeasterly side of Brownwood Drive, joint front corner Lots 147 and 148, and running thence N. 24-12 E. 159.7 feet to an iron pin, joint rear corner Lots 147 and 148; thence N. 65-54 W. 72.2 feet to an iron pin on Texas Avenue, thence along Texas Avenue, S. 29-12 W. 125 feet to an iron pin; thence around the curve of the intersection of Texas Avenue and Brownwood Drive, the chord of which is S. 18-18 E. 33.7 feet to an iron pin on Brownwood Drive; thence along Brownwood Drive, S. 65-48 E. 60 feet to an iron pin, the point of beginning.
