BEGINNING at a stake on the West side of said highway at the Northeast corner of James Street and running thence N. 12-50 E., 154.3 feet to a stake at the corner of lot 10; thence N. 74-00 W., 268.9 feet along the South side of lot 10 to a point on the line of lot 12; thence S. 14-55 W., 85.8 feet along the rear line of lot 12 to a point on the North side of James Street; thence S. 60-06 E., 284.3 feet along said street to the beginning corner.
