Baldwin, his heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina being known and designated as lot no. 106 of a subdivision known as Section "A" of Englewood Estates as shown by a plat thereof dated October, 1951, recorded in RMC Office for Greenville County, in Plat Book Y at page 140, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on Evelyn Drive and running S. 29-20 E. 117.7 feet to an iron pin on Evelyn Drive joint front corners of lots 106 and 107; thence along the line of lots 106 and 107 S. 87-30 E. 217.5 feet to an iron pin on the west side of lot 108; thence N. 2-30 E., 100 feet to an iron pin joint rear corners of lots 106, 108, 109 and 105; thence along the line of lots 106, 105, 104 and 103 N. 87-30 W. 279.3 feet to an iron pin on Evelyn Drive, the point of beginning.

- 1. No house is to be erected costing less than Five Thousand (\$5000.00) Dollars.
- 2. No house is to be built closer than fifty(50) feet to the street.
- 3. No temporary house is to be erected on said lot.

THIS deed is subject to any rights-of-way now existing. Grantee is to pay taxes for the year 1956.
