Luther M. McBee, Jr. and Floride McBee Stephenson, their heirs and assigns forever:

All my right, title and interest, which is an undivided one-fifth (1/5) interest in and to all that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the northerly side of Pettigru Street, in the City of Greenville, S. C., and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Pettigru Street at a point 145 feet east of the northeasterly corner of the intersection of Pettigru Street and Williams Street, and running thence N 15-1 W 90 feet to an iron pin; thence N 65-0 E 25 feet to an iron pin; thence N 15-1 W 110 feet to an iron pin on a 15 foot alley; thence with said alley N 65-0 E 52 feet to an iron pin; thence S 15-1 E 200 feet to an iron pin on the northerly side of Pettigru Street; thence along the northerly side of said Street S 65-0 W 77 feet to the point of beginning.
