All that piece, parcel or lot of land in Saluda Township, Greenville County, State of South Carolina, containing 8.5 acres, more or less, and shown on a plat of said property prepared by Terry T. Dill, Reg. L. S. in April 1957, and having, according to said plat, the following lines, courses and distances, to-wit:
