FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is LOUIS P. BATSON COMPANY

THIRD: That the principal place of business is GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is the manufacture and sale, either at retail or wholesale, either directly or as agents of industrial machinery, equipment and supplies, and the doing of all things incident to the prosecution of such a business.

FIFTH: That the amount of the capital stock is Two hundred thousand (\$200,000.00)-----Dollars payable in cash and property.

SIXTH: That the number of shares into which the capital stock is divided is Two thousand (2,000) of the par value of One hundred (\$100.00)------

NENTH: That all requirements of Title 12, Article 1, Chapter 2, Code of Laws of South Carolina, 1952, and all amendments thereto have been duly and fully complied with, 50 per cent, of the aggregate amount of the capital stock having been subscribed by hona fide subscribers, 20 per cent, of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in The Greenville News
