

James Ansel Copeland, his Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, in the Fairview Church community, lying on the northwest side of the road that leads from the Buncombe Road to the Rutherford Road, and being a part of the same land that was conveyed to me by deed from H. G. Copeland December 31st 1998, recorded in the R. M. C. office for Greenville County in Deed Book 11 at page 196, and having the following courses and distances, to wit:-
