

All that piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the western side of Taber Street and being known and designated as the major portion of Lot 22 according to a plat of Stone Estates made by C. M. Furman, Jr., dated December, 1931, and recorded in the R. M. C. Office for Greenville County in Plat Book G at Page 294, and having the following metes and bounds, to-wit:
