these presents do grant, bargain, sell and release unto the said Janet Lie Holder, her heirs and assigns forever, the following described property to wit:

All that tract of land in Pairis Mountain Township, situateon the Duncan Bridge Road, including the home site of the Grantor and all other land or lots remaining in the Grantor, being the remainder of the J, E. Thackston homeplace, as shown and set forth in Dood Book 307, page 69 by Deed of January 31, 1947. This conveyance includes the remainder of all lands unconveyed by me as shown in Plat Book GG, page 51, designated as No. 12131, Map No. 2, including my home site designated on said Map as "Dun-Thack" and all other lots from number 14 thru 34 remaining unsold, and including the remains of a twenty-two (22) acre tract, more or less, lying east, south and west, of the mapped property, herein referred to. It is the intention of the Grantor herein, to convey to the Grantee herein, all of his property remaining unsold which he heretofore acquired by Deed on January 31, 1947, recorded in Dead Book 307, page 69; also, all that piece, parcel or lot of land in Paris Hountain Township, Greenville County, State of South Carolina, known and designated as Lot No. 36 of subdivision known as Franklin Heights, shown on Plat recorded in Plat Book L, page 9 having the metes, bounds, courses and distances as are therein set forth which by reference are incorporated herein. This is the same property which the Grantor acquired by Deed of April 30, 1946, from Elizabeth J. McClenaghan and P. R. Long of record in Deed Book 291, page 25; also, all that certain tract of land in Highland Township, Greenville County, State of South Carolina, containing 41.29 acres, more or less, according to survey and plat by H. S. Brochman, Surveyor, dated July 31, 1936, and known thereon as tract No. 4 and having the metes, bounds, courses and distances as is set forth in Plat, same being by reference incorporated herein and made a part hereof. The Grantor acquired said property by Deed executed on January 2, 1952, recorded in the aforesaid Register of Main Conveyances for Greenville County in Deed Book 448, page 357; also all that tract of land in the aforesaid county and state in Paris Mountain Township, lying and being on the south side of Hunts Bridge Road known and designated as tract No. 2 of the Elvira Shockley property, as shown in subdivision and Plat of August 31, 1927, recorded in Plat Book H, page 115, containing 31.75 acres, more or less. The metes, bounds, courses and distances as is set out in said Plat are by reference incorporated herein and made a part hereof. This isthe same property which the Grantor acquired by Dead of February 5, 1929, of record in the above county and state in Decd Book Vol. 134, page 160. Also, all that certain tract of land in Paris Mountain Township of the above County and State, on Saluda River, being part of the Warren Hunt Place and being known and designated as as tract No. 1 as shown by survey and Plat of same of record in Plat Book J, at page 39. The metes, bounds, courses and distances as are set out in said Plat Book are by reference incorporated herein and made a part hereof. This is the same property which the Grantor acquired by Dead of Purchase executed on November 19, 1940 and of record in Decd Book 227, page 330; also, all that certain piece, parcel or lot of land in the aforesaid county and state, situate lying and being in Chick Spring Township, Paris School District designated as Lot No. 2, adjoining properties of the P & H Railroad, just outside the City Limits of Greenville, being the land or a part thereof, which, the Grantor acquired by Dand of record in the aforesaid County and State in Deed Book
