to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. M. Barrington, his heirs and assigns forever:

All that certain piece, parcel or lot of land situated in Austin Township, Greenville County, State of South Carolina just North of the Town of Simpsonville, S. C. and being lot No. 77 in a subdivision of lands known as Forest Park and shown as lot No. 77 on a plat entitled Map of Forest Park, prepared by C. O. Riddle, Surveyor, October, 1952 and recorded in the R. M. C. Office for Greenville County in Plat Book BB, Pages 70 and 71 and according to said plat having the following metes and bounds:

Beginning at an iron pin on the North side of Forest Park Drive and running thence N. 13-23 W. 111.4 ft. to an iron pin on the South bank of a branch and running along the same course 17.9 ft. to the center of said branch, then running along said branch as a line by a traverse line N. 89-46 W. 137.2 ft. to a point in the center of branch; thence S. 3-46 E. 144 ft. to an iron pin on the North side of Forest Park Drive at the joint front corners of lots Nos. 77 and 78; thence running along the right-of-way of Forest Park Drive N. 86-14 E. 70 ft. to an iron pin; thence continuing along the right-of-way of Forest Park Drive N. 80-32 E. 52 ft. to the beginning point which is at the joint front corners of lots Nos. 76 and 77.

This property is conveyed subject to the restrictions fully set forth in the deed by which R. D. Coker acquired this property from Jeff R. Richardson, Trustee by deed dated 14 June, 1954 and recorded in the R. M. C. Office for Greenville County in Deed Book 501, Page 319.

This is the same property conveyed to the grantor by R. D. Coker, by deed dated March 15, 1957 and recorded in the R. M. C. Office for Greenville County in deed book 575, page 269.
