EEGINNING at an iron pin in the West side of the Hunts Bridge Road (sometimes called Cedar Lane Road) which pin is 339.1 feet North of the intersection of Hunts Bridge Road and Franklin Road, at the joint front corner of Louise Green and Lot No. 4 as shown on the plat above referred to and running thence with the Hunts Bridge Road, N. 7-15 W. 105 feet to an iron pin in line of land now or formerly of Hodgens Estate; thence with line of said lands, N. 53-40 W. 295.3 feet to an iron pin in line of property now or formerly of Cunningham; thence with line of said property, S. 47-55 W. 171 feet to iron pin, rear former of Lot 4; thence with line of said lot, S. 66-24 E. 410.6 feet to the point of beginning.

This being the same property conveyed to the grantors by deed of Curtis Tanner recorded in Vol 510, at page 474.
