

ALL that piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, being known and designated as Lot No. 12 on plat of property of Chestnut Hills, recorded in the Office of the R. M. C. for Greenville County in Plat Book GG, page 35; and being more particularly shown on plat of property of Joseph D. RaPosa, dated June 14, 1956, prepared by R. K. Campbell, and having according to said plat the following metes and bounds, to-wit:
