All that piece, parcel or lot of land, with improvements, located in Greenville Township, County and State aforesaid and being known and designated as Lot No. ll on Henrydale Avenue in a sub-division known as "Woodland", property of Piedmont Corporation; as per plat made by Dalton and Neves, dated February, 1938 and recorded in the R.M.C. Office for Greenville County in Plat Book J, at Page 70 and having, according to said plat, the following metes and bounds:
