All that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the East side of McCuen Street (formerly Mitchell Street), in the City of Greenville, being a portion of Block K on Plat of Kanatenah, recorded in the R. M. C. Office for Greenville County in Plat Book F, at page 131, and according to a survey made by Piedmont Engineering Service on March 15, 1952, is described as follows:

BEGINNING at a stake on the Eastern side of McCuen Street, 79.9 feet North from Stewart Street, at corner of property of Charles M. Trost and running thence with the line of said lot, N. 71-04 E. 105.4 feet to a stake; thence N. 24-42 W. 84.9 feet to a stake; thence S. 60-21 W. 84.5 feet to a stake on McCuen Street; thence with the Eastern side of McCuen Street, S. 7-17 E. 69.9 feet to the beginning corner.
