

ALL That piece, parcel or lot of land situate, lying and being on the South-eastern side of Cottingham Street near Monaghan Mills in the County of Greenville, State of South Carolina, being known and designated as Lot No. 56 as shown on a plat entitled "Monaghan Subdivision, Greenville, S.C.", made by Piedmont Engineering Service, Greenville, S. C., August 9, 1954, and recorded in the R.M.C. Office for Greenville County in Plat Book GG, at pages 86 and 87, and having according to said plat the following metes and bounds:

BEGINNING At an iron pin on the Southeastern side of Cottingham Street at the joint front corner of Lots Nos. 55 and 56, and running thence with the line of Lot No. 55, S. 13-28 E. 156.9 feet to an iron pin in the line of Lot No. 53; thence with the line of Lot No. 53, S. 79-06 E. 40.5 feet to an iron pin in the rear line of Lot No. 51; thence with the rear lines of Lots Nos. 51 and 50, N. 54-50 E. 46.8 feet to an iron pin at the joint rear corner of Lots Nos. 56 and 57; thence with the line of Lot No. 57, N. 13-28 W. 156.3 feet to an iron pin on the Southeastern side of Cottingham Street; thence with the Southeastern side of Cottingham Street, S. 76-32 W. 80 feet to the point of beginning.

This is the same property conveyed to grantor herein by deed of J.P.Stevens & Co., Inc., dated Oct. 1, 1957, and recorded Oct. 16, 1957, in the Office of the R.M.C. for Greenville County in Deed Book 586, Page 101.

Stevens & Co., Inc. to Duke Power Co., recorded in Deed Book 510, Page 317.
