All that piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Southeastern corner of the intersection of East Earle and Elizabeth Streets and being known and designated as Lot No. 36 of the lands of Mountain City Land and Improvement Company, as shown on plat prepared by J. N. Southern dated February 20, 1891 and recorded in the R. M. C. Office for Greenville County in deed Book "VV", at Page 543, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Southeastern corner of the intersection of East Earle and Elizabeth Streets and running thence along the South side of East Earle Street S. 73 E. 54 1/2 feet to a stake; thence S. 17 W. 206 1/2 feet to a stake; thence N. 73 W. 54 1/2 feet to a stake on Elizabeth Street; thence with Elizabeth Street N. 17 E. 206 1/2 feet to the point of beginning.
