All that piece, parcel or tract of land in Butler Township, Greenville County, state of South Carolina, on both sides of South Carolina Highway No. 296, and on the northwest side of a county road, containing 24.55 acres, as shown on plat made by C. O. Riddle, March 31, 1958 and having according to said plat the following metes and bounds. following metes and bounds, courses and distances, to-wit:
