



her heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, and known and designated as Lot No. 124 on the plat of Green Valley Subdivision, prepared by Piedmont Engineering Company, and dated December 20, 1957, which plat is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ, at pages 2 and 3, and which lot by reference to said plat is more particularly described as follows:

BEGINNING at an iron pin in the East line of West Round Hill Road, joint front corner of Lots Nos. 123 and 124, and running thence along the East line of said road two arcs (the chords of which are N 16-58 E 115 feet and N 29-59 E 115 feet) to an iron pin, joint front corner of Lots Nos. 124 and 125; thence along the joint line of said lots S 55-14 E 271.1 feet to an iron pin, joint corner of Lots Nos. 124, 125 and 129; thence along the joint line of Lots Nos. 124 and 129 S 1-17 E 114 feet to an iron pin, joint corner of Lots Nos. 123, 124, 129 and 130; thence along the joint line of Lots Nos. 123 and 124 N 79-18 W 321 feet to the point of beginning.

This lot is subject to the protective covenants covering the Green Valley Subdivision which are recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 593, at page 297 (a copy of these covenants is being delivered to grantee along with this deed) and to any recorded easements or rights of way.
