All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, State and County aforesaid, on the Southern side of West Parker Road, designated as Lot # 17, Block C of Hughes Heights Subdivision, as shown on a plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book "GG" at pages 122-123, and having according thereto the following metes and bounds, to-wit:

BEGINNING at a concrete monument on the Southern side of West Parker Road at the joint front corner of Lots 16 and 17, and running thence along the line of said lots S. 26-26 W. 167.7 feet to an iron pin on a service drive; thence along said drive N. 56-30 W. 101.7 feet to an iron pin; thence along the line of Lot # 18, N. 34-54 E. 163.3 feet to an iron pin; thence along West Parker Road S. 58-47 E. 77 feet to the point of beginning.

The above described property is subject to restrictions applicable to Hughes Heights Subdivision, recorded in the R.M.C. Office for Greenville County in Deed Book 526 at page 462. The subject premises constitute a portion of the real estate owned by T.T. Hughes at the time of his death. The said T.T. Hughes died testate on July 24, 1951, his Will being of record in the office of the Probate Court for Greenville County in Apt. 603, File 10.
