

Sloan" and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book PP at page 189, the following metes and bounds:

BEGINNING at an iron pin on the northeastern edge of the right of way of the C. & W. C. Railroad at the southwestern corner of the tract herein conveyed and in the line of property now or formerly of Greenville Concrete Co. and running thence with the line of the said Greenville Concrete Co. property N. 48-50 E. 30 feet to an iron pin; thence with the line of other property of the Grantor herein S. 43-46 E. 120.1 feet to an iron pin on the northeastern edge of the right of way of the C. & W.
