FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is PARA-CHEM SOUTHERN, INC.

THIRD: That the principal place of business is GREENVI LLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to process, create, develop, compound, treat, produce, improve, prepare for market, distribute, export, import, transport, use, store and in any other manner deal in and deal with, at wholesale or retail, as principal, agent, broker, licensee or otherwise, lubricating and industrial oils, lubricants of all kinds, petroleum products and any derivatives or by-products thereof, chemicals, chemical preparations, compounds, wetting agents, synthetic detergents and any products or by-products that may be derived from any of the foregoing products, now known or that may hereafter be discovered or developed; to carry on the business of chemists, manufacturers, distributors, processors, jobbers, importers, and exporters of any or all of the articles or products herein named; to carry on, conduct and develop research and experimental work and to acquire, by purchase, lease or otherwise, and to erect, construct, improve, develop, lease, mortgage, convey, maintain and operate buildings, manufacturing plants, factories, laboratories, research agencies, distributing stations, service facilities and warehouses with suitable equipment, machinery and facilities necessary or convenient for the business of the corporation.

FIFTH: That the amount of the capital stock is Two Hundred Fifty Thousand (\$250,000.90)-Dollars payable in cash or property when called for by the Board of Directors.

SINTH: That the number of shares into which the capital stock is divided is Twenty-five Hundred (2500)

of the par value of One Hundred (\$100.00)-----

SEVENTH: That, after due notice, a meeting of the subscribers was held on the
