All those two certain lots or parcels of land in Ward 1 of the City of Greenville, County of Greenville, State of South Carolina, described according to plat of property of Perry S. Luthi made September 1958, having the following metes and Bounds, to wit:

BEGINNING At an iron pin on the Northeasterly side of West Washington Street said iron pin being 76.5 feet in a Southeasterly direction from the intersection of Echols Street and West Washington Street and running thence N. 54-40 E. 107.8 feet to an iron pin; thence S. 45-54 B. 54.7 feet to an iron pin; thence S. 38-23 W. 100 feet to an iron pin on West Washington Street; thence along West Washington Street N. 50-45 W. 84.8 feet to an iron pin, the point of beginning.
