

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J. P. MEDLOCK, His Heirs and Assigns;

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 13 of the property of W. T. Patrick and William R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book PP at Page 131, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Lawnview Court at the joint front corner of Lots 13 and 14 and running thence S 34-20 E 165 feet to a point at the joint rear corner of Lots 13 and 14; thence S 55-40 W 125.7 feet to a point at the rear corner of Lot 13; thence N 25-13 W 167.1 feet to a point on the Southeastern side of Lawnview Court at the present Southwest end of Lawnview Court; thence with the Southeastern side of Lawnview Court N 55-40 E 12.4 feet to a point; thence following the curvature of the Southeastern side of a turnaround on Lawnview Court (the chords of which are N 85-40 E 50 feet and N 25-40 E 50 feet) to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

GRANTEE to pay 1959 taxes.

The grantees also convey all their right, title and interest in and to that portion of the turnaround in front of the within lot, which will become a part of said lot if Lawnview Court is ever extended.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and His Heirs and Assigns forever.
