Beginning at an iron pin on the southeast side of Glenn Road, the front joint corner of Lots Nos. 15 and 16 of the Glenn Farms plat; thence with the joint line of said lots S. 30-00 E. 200 feet to an iron pin; thence turning S. 83-47 W. 60 feet to an iron pin corner of lot No. 2 on the Cannon plat; thence with the line of said lot N. 28-37 W. 169 feet to an iron pin on the southeast side of Glenn Road; thence with the southeast side of said road N. 54-24 W. 50.2 feet to the beginning corner.
